**This Optional Cash Purchase Notice (“OCP Notice”) form must be submitted by the Participant of CDS Clearing and Depository Services Inc. (“CDS”) through which Units are held.**

OCP instructions received after the Distribution Record Date will not be effective in respect of that Distribution Payment Date but effective for the next Distribution Payment Date. Defined terms have the meanings given to them in the Distribution Reinvestment Plan.
