Investment Objective and Strategy

The fundamental investment objective of **First Trust NASDAQ® Clean Edge® Green Energy ETF** (the “First Trust ETF”) is to replicate, to the extent possible, the performance of an index of U.S. listed companies designed to track the performance of clean energy companies engaged in manufacturing, development, distribution and installation of clean-energy technologies including, but not limited to, solar photovoltaics, wind power, advanced batteries, fuel cells, and electric vehicles, initially the NASDAQ® Clean Edge® Green Energy IndexSM.

The NASDAQ® Clean Edge® Green Energy IndexSM is a modified market capitalization weighted index designed to track the performance of clean energy companies that are publicly traded in the United States and includes companies engaged in manufacturing, development, distribution and installation of emerging clean-energy technologies including, but not limited to, solar photovoltaics, wind power, advanced batteries, fuel cells, and electric vehicles.

Risk

The First Trust ETF provides exposure to its index by investing all or substantially all of its assets in an underlying U.S. index fund known as First Trust NASDAQ® Clean Edge® Green Energy Index Fund (the “Underlying Fund”), which is managed by the First Trust ETF's portfolio advisor.

The risks associated with an investment in the First Trust ETF is discussed in the First Trust ETF's most recent prospectus.

Results of Operations

General

The First Trust ETF's net asset value as of June 30, 2026, was \$8,224,845 or \$28.36 per unit. The First Trust ETF's net asset value as of December 31, 2025, was \$4,996,426 or \$19.99 per unit.

For the six-month period ended June 30, 2026, the First Trust ETF paid total cash distributions of \$0.0100 per unit. There were no cash distributions declared for the record date June 30, 2026, by the First Trust ETF.

Investment Performance

For the six-month period ended June 30, 2026, the First Trust ETF returned 41.98% compared to the S&P 500® Index (the “benchmark”) return of 14.07%. Unlike the benchmark, the First Trust ETF's return is net of fees and expenses.

The First Trust ETF's only holding, the Underlying Fund, held 52 equity securities as of June 30, 2026. The top ten equity holdings for the Underlying Fund accounted for 58.64% of the portfolio within the Underlying Fund.

The Underlying Fund outperformed the benchmark during the period due to stock selection, primarily within the Industrials and Information Technology Sectors. Sector allocation was a positive to performance relative to the benchmark. At the industry level, overweight positions in the Electrical Equipment and Semiconductors & Semiconductor Equipment industries contributed positively to performance.

The Underlying Fund's top five stocks by contribution to return were Bloom Energy Corporation, ON Semiconductor Corporation, Vicor Corporation, Allegro MicroSystems, Inc., and Monolithic Power Systems, Inc. The Underlying Fund's bottom five stocks by contribution to return were Rivian Automotive, Inc., First Solar, Inc., Eos Energy Enterprises, Inc., Tesla, Inc., and Universal Display Corporation.

The First Trust's ETF's exposure to the U.S. dollar contributed to its absolute performance during the period, as the U.S. dollar appreciated 3.55% against the Canadian dollar from December 31, 2025, to June 30, 2026.

Recent Developments

The clean energy industry outperformed the broader equity market in the first half of 2026. The First Trust ETF gained 41.98% through June versus a return of 14.07% on the S&P 500® Index. The First Trust ETF's outperformance was primarily driven by Artificial Intelligence ("AI") adjacent exposures in the clean energy space that benefitted from the buildout of AI infrastructure. For example, about 49% of the First Trust ETF's outperformance was driven by Bloom Energy ("Bloom"). Bloom is a manufacturer of fuel cells which produce electricity through a chemical reaction requiring no combustion. The industry is rather nascent, and Bloom is an industry leader, the firm's stock rallied 248.4% through June, driven by data centers adopting fuel cell technology as a behind the meter electricity source. Similarly, about 20% of the First Trust ETF's outperformance was driven by ON Semiconductor Corporation which rose along with the broader Semiconductor industry as AI demand for compute has driven Semiconductor revenues higher. While the current U.S. administration has shown disdain toward the clean energy industry, removing tax subsidies, the industry has benefitted from certainty. When the administration came into power, outlook was rather opaque and certainty regarding tax subsidies while negative removed the overhang of impending action. The industry has also benefitted from the AI buildout as grid interconnection times have swollen in recent years. At the end of 2025 median interconnection times were over five years compared to under two years in 2008. The AI buildout has prioritized speed to market as hyperscalers compete in a fast-moving industry and attempt to gain market share. Alternative energy companies have benefitted as long grid interconnection times are effectively unacceptable by AI companies. Data centers have turned to solar and storage, fuel cells, gas turbines, and other alternative electricity sources in order to bring data centers online faster. Lastly, alternative energy sources have benefitted from recent volatility in the fossil fuel market. The conflict in Iran has pressured oil prices which causes businesses to rethink long term reliance on geopolitical sensitive energy sources. Looking ahead many clean energy companies are considered "long duration" equities or stocks that benefit from lower rates as cash flows are expected to mature in the future. Inflation expectations have increased since the start of the year and the market is currently pricing rate increases rather than cuts although the Fed has not indicated they're set on raising rates. This is a key risk looking ahead along with continued legislative pressures and AI Capital Expenditure potentially peaking.

The Manager has retained the Advisor to provide certain services to the First Trust ETF pursuant to an investment advisory agreement. The Advisor receives advisory fees from the Manager out of the management fee.

Management Fees

The First Trust ETF will pay the Manager a management fee of 0.15% based on the average daily NAV of the First Trust ETF. The management fee, plus applicable taxes including HST, will be accrued daily and paid monthly in arrears. The Manager may, from time to time in its discretion, waive all or a portion of the management fee charged at any given time.

The First Trust ETF's management fee will also bear the management fee of the Underlying Fund.

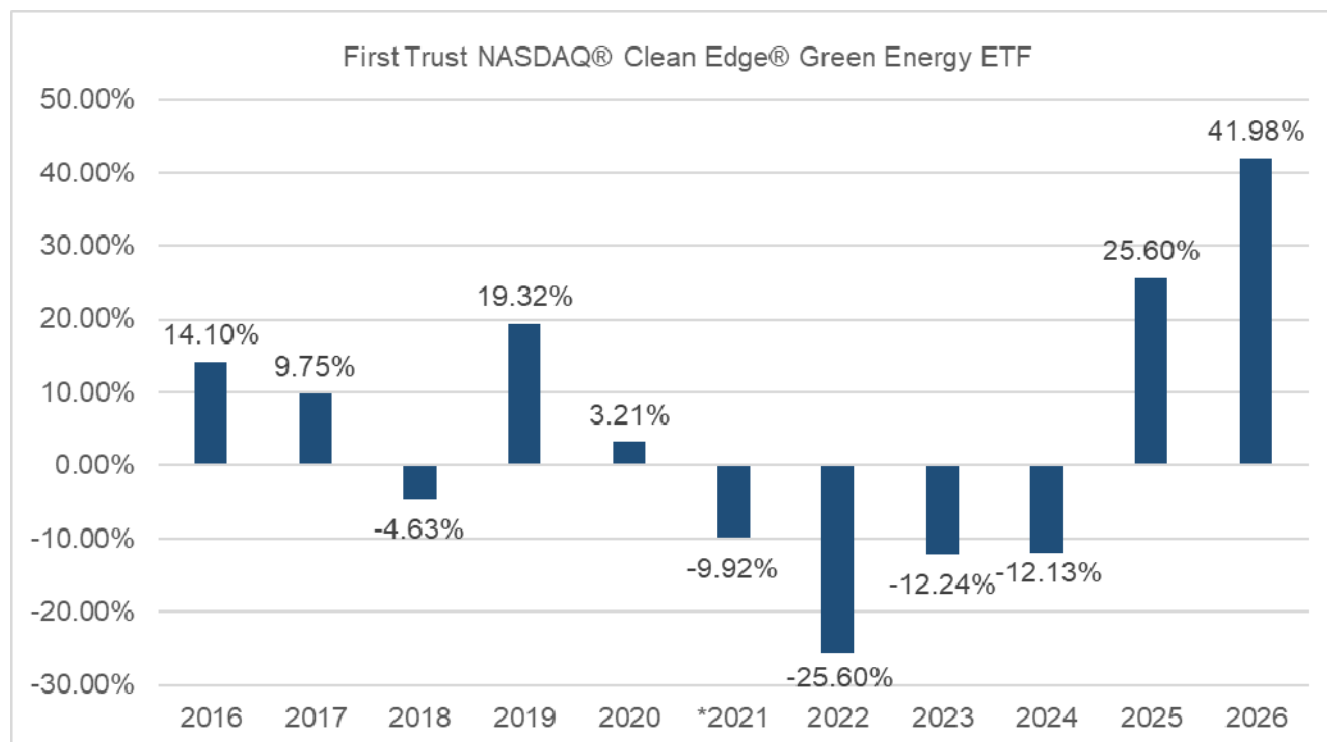
Past Performance
