### Investment Objective

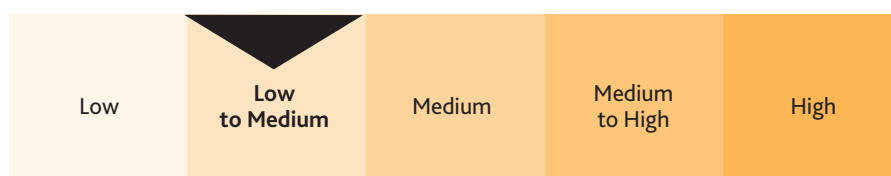
**First Trust Global Risk Managed Income Index ETF** seeks to replicate, to the extent possible, the performance of the NASDAQ Global Risk Managed Income CAD TR Index (the "Index"), net of expenses. The investment strategy of the First Trust ETF is to invest in and hold the constituent securities of the Index in the same proportion as they are reflected in the Index or securities intended to replicate the performance of the Index. The Index is a values-based, quantitatively enabled index that seeks to provide exposure to income generating securities within a risk managed framework by investing in exchange traded funds that meet specific criteria and trade on the Toronto Stock Exchange.

### Risk rating

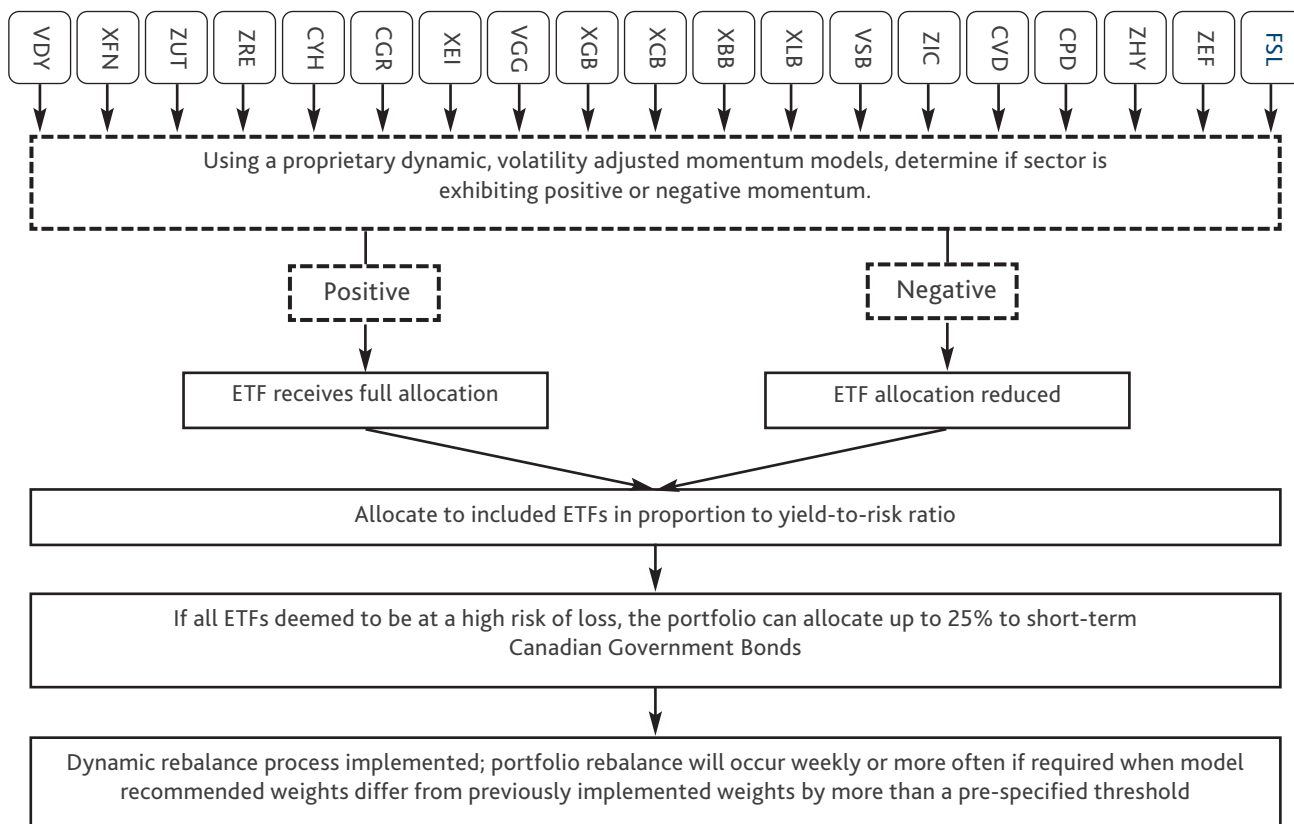
