

# **Investment Objective and Strategy**

The fundamental investment objective of **First Trust Indxx NextG ETF** (the "First Trust ETF") is to replicate, to the extent possible, the performance of an index of U.S. companies that have devoted or have committed to devote, material resources to the research, development and application of fifth generation and next generation digital cellular technologies as they emerge, initially the Indxx 5G & NextG Thematic Index<sup>SM</sup>.

The Indxx 5G & NextG Thematic Index<sup>SM</sup> is designed to track the performance of companies that have devoted, or have committed to devote, material resources to the research, development and application of fifth generation and next generation digital cellular technologies as they emerge. Eligible securities must have a minimum market capitalization of US\$500 million, six-month average daily trading volume of at least US\$2 million (US\$1 million for emerging market companies), traded for at least 90% of the total trading days in the last six months or for a security recently issued in an initial public offering over the prior three months, a minimum free float of 10% of shares outstanding and a share price of less than US\$10,000 for new index constituents.

### Risk

In February 2021, the First Trust AlphaDEX™ U.S. Energy Sector Index ETF changed its investment objectives (see Investment Objective and Strategy) and its name to the First Trust ETF. The First Trust ETF provides exposure to its new index by investing all or substantially all of its assets in an underlying U.S. index fund known as First Trust Indxx NextG ETF (the "Underlying Fund"), which is managed by the First Trust ETF's portfolio advisor. The effective date of change is February 17, 2021.

The risks associated with an investment in the First Trust ETF is discussed in the First Trust ETF's most recent prospectus.

# **Results of Operations**

#### General

The First Trust ETF's net asset value as of December 31, 2021 was \$2,438,320 or \$9.75 per unit. The First Trust ETF's net asset value as of December 31, 2020 was \$1,080,053 or \$7.20 per unit.

There were no cash distributions paid nor declared for the year ended December 31, 2021.

### **Investment Performance**

For the year ended December 31, 2021, the First Trust ETF returned 35.45% compared to the MSCI ACWI Information Technology Index (the "benchmark") return of 26.18%. Unlike the benchmark, the First Trust ETF's return is net of fees and expenses.

The First Trust ETF outperformed the benchmark during the period mostly due to a significant overweight allocation to Energy, which significantly outperformed the benchmark, prior to the change. After the change, the First Trust ETF underperformed the benchmark, mostly due to a significant overweight position in Communication Services. Stock selection within the information technology sector served to further the First Trust ETF's underperformance.

The First Trust ETF's only holding, the Underlying Fund, held 99 equity securities as of December 31, 2021. The top ten equity holdings for the Underlying Fund accounted for 13.28% of the portfolio within the Underlying Fund.

The Underlying Fund's top five stocks by contribution to return were NVIDIA Corporation, Arista Networks, Inc., Marvell Technology, Inc., Tech Mahindra Limited, and Wipro Limited Sponsored ADR. The bottom five stocks by contribution to return were GDS Holdings Ltd. Sponsored ADR Class A, Xiaomi Corp. Class B, China Tower Corp. Ltd. Class H, SAMSUNG SDS CO. LTD., and NEC Corp.

# **Recent Developments**

In February 2021, the First Trust AlphaDEX<sup>TM</sup> U.S. Energy Sector Index ETF changed its investment objective to seek to replicate, to the extent possible, the performance of an index of U.S. companies that have devoted or have committed to devote, material resources to the research, development and application of fifth generation and next generation digital cellular technologies as they emerge, the Indxx 5G & NextG Thematic Index<sup>SM</sup>. The proliferation of 5G, the next-generation wireless network, is underway and offers investors attractive investment opportunities. Where previous generations of networks enabled the advent of modern applications used in consumer-facing smart phones, the power of 5G will cast across multiple end markets including industrial automation, health care, and smart cities. These 5G-enabled industries have the potential to add \$8 trillion to the global GDP by 2030 which creates an enticing growth opportunity for companies supporting 5G's development. After an \$82 billion spectrum auction in February 2021, Tier 1 Service Providers in the United States regained their 2019 level of capital expenditures as they continue to build out their networks. An estimated 60% of Tier 1 cities will have 5G coverage by 2024, according to Gartner. 5G networking and the industries that support new connected devices remain an attractive theme as 5G investments, devices, and applications accelerate over the next several years.

# **Related Party Transactions**

FT Portfolios Canada Co. is the Manager of the First Trust ETF and is a Canadian affiliate of First Trust Advisors L.P., the investment advisor (the "Advisor") of the First Trust ETF.

Pursuant to terms of the declaration of trust of the First Trust ETF, the Manager provides or arranges for all management, administrative and other services required by the First Trust ETF. The Manager receives a management fee from the First Trust ETF. For further details, please see "Management Fees".

The Manager has retained the Advisor to provide certain services to the First Trust ETF pursuant to an investment advisory agreement. The Advisor receives advisory fees from the Manager out of the management fee.

This includes the First Trust ETF's proportionate share of the commissions of any underlying fund in which the First Trust ETF has invested.

<sup>(3)</sup> The First Trust ETF's portfolio turnover rate indicates how actively the First Trust ETF's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the First Trust ETF buying and selling all of the securities in its portfolio once in the course of the year. The higher a First Trust ETF's portfolio turnover rate in a year, the greater the trading cost payable by the First Trust ETF in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between high turnover rate and the performance of a First Trust ETF.

# **Management Fees**

The First Trust ETF will pay the Manager a management fee of 0.15% based on the average daily NAV of the First Trust ETF. The management fee, plus applicable taxes including HST, will be accrued daily and paid monthly in arrears. The Manager may, from time to time in its discretion, waive all or a portion of the management fee charged at any given time.

The First Trust ETF will bear the Underlying Fund's management fee of 0.70% per annum on average daily net assets on the First Trust ETF's portfolio assets invested in the Underlying Fund. Accordingly, the management fee cost to unitholders of their investment will be 0.85% per annum of NAV of the First Trust ETF plus applicable taxes.

#### **Past Performance**


#### General

The index is built using MSCI's Global Investable Market Index (GIMI) methodology, which is designed to take into account variations reflecting conditions across regions, marketcap sizes, sectors, style segments and combinations. 
