Investment Objective

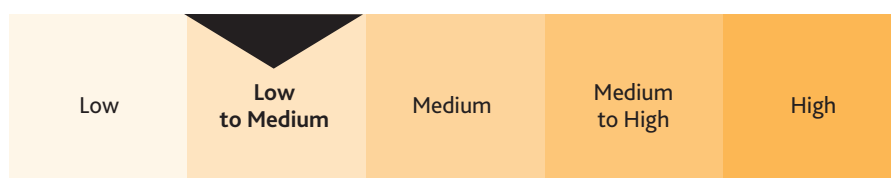
First Trust Short Duration High Yield Bond ETF (CAD-Hedged) seeks to provide Unitholders with a high level of current income by investing primarily in a diversified portfolio of below investment grade debt securities as rated by Moody's Investor Services, Inc., and Standard & Poors (Ba1/BB+ or below) or a similar rating by a designated rating organization (as defined in NI 81-102). As a secondary objective, the fund will seek capital appreciation.

Key Features

- Primarily invests in high yield issuers in the U.S., targeting a high level of interest income and the potential for capital appreciation
- Actively managed portfolio with a diversified portfolio of high yield bonds, floating rate loans and other debt securities
- Portfolio managers for the fund have proven experience and expertise at managing the challenges and opportunities in high yield bond investments
- Monthly income stream

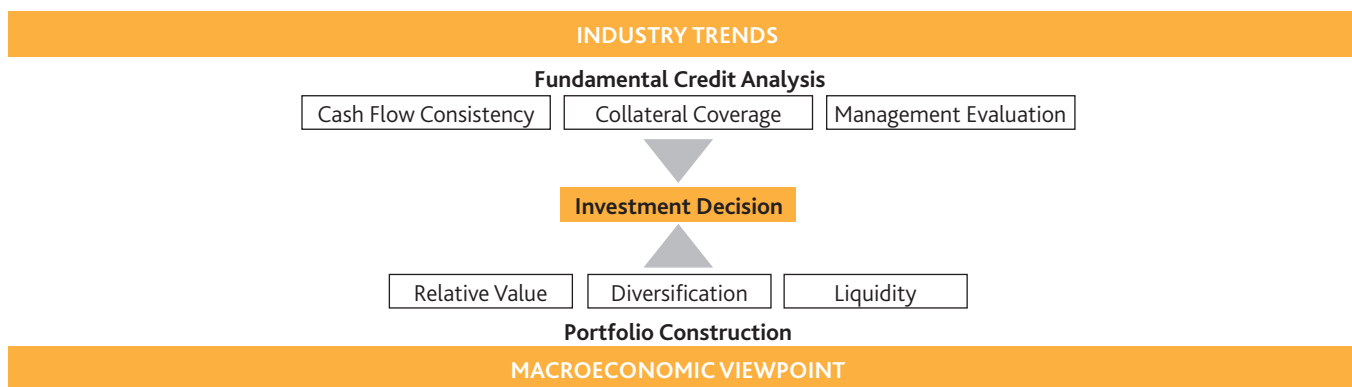
