Investment Objective

The First Trust AlphaDEX™ U.S. Consumer Staples Sector Index ETF seeks to replicate, to the extent possible, the performance of the StrataQuant® Consumer Staples Index (the "Index"), net of expenses. The investment strategy of the First Trust ETF is to invest in and hold the constituent securities of the Index in the same proportion as they are reflected in the Index or securities intended to replicate the performance of the Index. The Index employs the AlphaDEX™ stock selection methodology to select stocks from the Russell 1000® Index that are within the consumer staples sector. The Russell 1000® Index is a market index representing the large- and mid-capitalization segment of the U. S. equity universe.

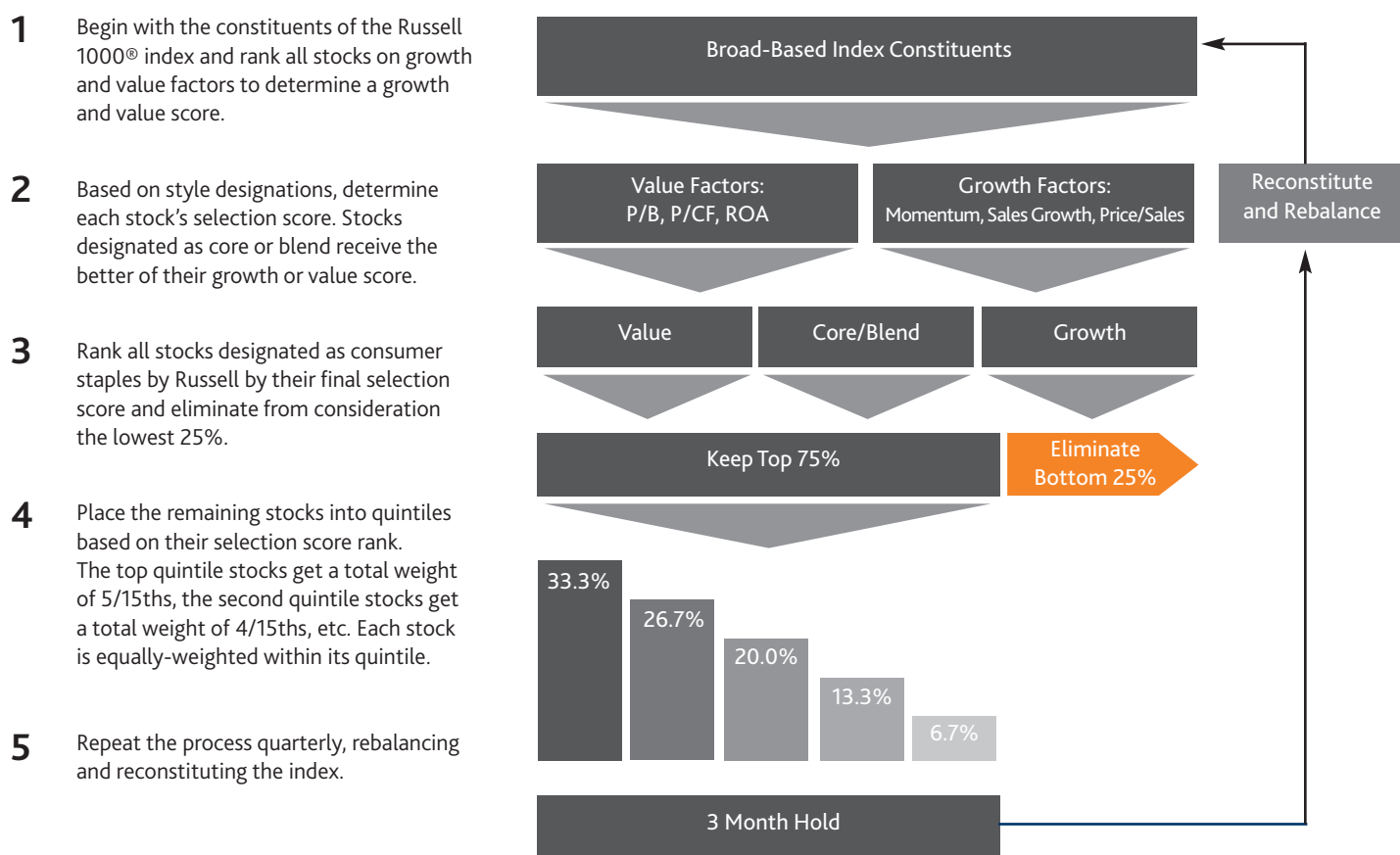
²FT Portfolios Canada Co. uses a harmonic weighted average method for calculating the price ratios for an investment portfolio except for Return on Equity which uses weighted arithmetic mean. The harmonic weighted average method measures the valuation of the portfolio as a whole, for example, the total "price" of the portfolio to the total earnings purchased. For example, for P/E, it is the ratio of the portfolio's total market value in equities to its share of the underlying stocks' earnings. This method evaluates the entire portfolio like a single stock and it minimizes the impact of outliers.

³ Distribution rate is calculated by dividing the most recent annualized distribution paid or declared by the Net Asset Value. Distribution rates may vary. The distributed amount may include return of capital (ROC) from time to time.

AlphaDEX™ U.S. Consumer Staples Sector Index Methodology

The indexes which provide the basis for the AlphaDEX™ exchange-traded funds start with a broad-based index and are enhanced through the use of the proprietary AlphaDEX™ stock selection methodology. This methodology is designed to use value and growth factors to select and weight stocks based on their investment merit. The methodology used to select the stocks for the indexes is described in the chart below.
